### AVAILABILITY

Available for metered or otherwise measured service for irrigation, sprinkling or flushing when water is hauled from connection provided for such purpose, or from municipal fire hydrants at option of the Utility. This service is provided for installations where water usage does not enter the sewer system and sewer is not changed. Effective for all billings of this rate class rendered on or after October 1, 2008.

##### **3/4" Meter**

FIRST 10,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 10,000 Gallons	\$2.60/1,000 Gallons

##### **1" Meter**

FIRST 25,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 25,000 Gallons	\$2.60/1,000 Gallons

##### **1 1/2" Meter**

FIRST 50,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 50,000 Gallons	\$2.60/1,000 Gallons

##### **2" Meter**

FIRST 80,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 80,000 Gallons	\$2.60/1,000 Gallons

##### **3" Meter**

FIRST 160,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 160,000 Gallons	\$2.60/1,000 Gallons

**4" Meter**

FIRST 250,000 Gallons or Less	\$2.30/1,000 Gallons Plus
ALL over 250,000 Gallons	\$2.60/1,000 Gallons

**PAYMENT**

Bills for service rendered hereunder are payable within fourteen (14) days from due date and if not paid within such period become delinquent and subject to charges as set forth in the Utility's Rules and Regulations.

**TAX PROVISIONS**

In the event any privilege, license, franchise, use, occupational, or other similar tax is imposed upon the Utility by any governmental authority, either Federal, State or local, in excess of those in effect on July 1, 1987, there shall be added to the above rates and charges, an amount, calculated on a pro-rata basis, sufficient to recover any such tax or taxes.

**TERM OF CONTRACT**

Service under this classification shall be for an initial period of at least one year and thereafter from year to year until terminated by written notice.
