### APPLICABILITY

Applicable for service to restaurants, lounges, taverns or other similar commercial establishments. Service shall not be resold or shared with others.

### MONTHLY RATE

Basic Plus Service (Note 1) ..... \$47.95

NOTE 1: Fox Sports South and Sports South requires an additional 37.50 charge to a restaurant or lounge for each of their programming channels to be included in our Basic Plus package. Riviera Utilities Cable will block this service unless an establishment wants to add Fox Sports South or Sports South to their Basic Plus service. If an establishment wants the Fox Sports South and/or Sports South programming, the total monthly charge for Basic Plus service will be \$41.95 plus an additional \$37.50 for each sports channel selected for viewing.

NOTE 2: Premium Service(s) are not available to any subscriber under this rate classification.

### INSTALLATION REQUIREMENTS

Subscriber is responsible for the installation of each outlet and cabling to Riviera's point of service. Cable will be furnished by Riviera at no cost to the subscriber.

### UNDERGROUND SERVICE CHARGES

\$20.00 plus \$.50 per linear foot

NOTE: Subscriber is responsible for the cost of installation of necessary conduits, including those required under paved surfaces. Whenever boring under obstacles is required by Riviera, subscriber shall pay as follows:

Sidewalk, 4' or less . . . . . \$15.00  
 Private Paved Driveway, 12' width or less . . . . \$40.00  
 Public Street, Driveway more  
 than 12' wide, or other obstacles . . . . . Actual Cost

### PAYMENT

Bills for service rendered hereunder are payable within fourteen(14) days from due date and if not paid within such period become delinquent and subject to termination as set forth in Riviera's Rules and Regulations. If service is terminated due to non-payment, applicable collection and re-connection charges shall be payable in addition to balance due before service will be restored.

### TAX PROVISIONS

In the event any privilege, license, franchise, use, occupational, or other similar tax is imposed upon Riviera by any governmental authority, either Federal, State or local, in excess of those in effect on October 1, 2000, there may be added to the above rates and charges, an amount, calculated on a pro-rata basis, sufficient to recover any such tax or taxes.

### GENERAL

This rate schedule supercedes and replaces Rate "5-2", Monthly Rate "C", Fifth Revision, dated April 1, 2007, and applies to all billing rendered for general service - restaurant/lounge on or after July 1, 2009, and shall continue from month to month until rescinded.

### MINIMUM SERVICE PERIOD

Charges for services provided the subscriber hereunder shall not be for less than one month following the date of installation thereof.
