### AVAILABILITY

Available in all areas served by the Utility's transmission and/or distribution systems. The utility, being subject to the dictates of its suppliers and governmental agencies, both state and federal, regarding quantity and "end-use" of this commodity consequently makes no commitment that service will be continuous.

### APPLICABILITY

Applicable for service on an interruptible basis to industrial consumers engaged primarily in a process that creates or changes raw or unfinished materials into another form or product or consumption is significant as determined by the utility. Qualification for this rate requires minimum monthly usages of 200 CCF or greater. Service shall not be resold or shared.

### MONTHLY RATE

Basic Charge of \$500.00; plus

\$0.65 per 100 cubic feet for the first 10,000,000 cubic feet; plus

\$0.55 per 100 cubic feet for all over 10,000,000 cubic feet

### MINIMUM MONTHLY BILL

Monthly bills for service provided hereunder will not be less than \$500.00

### PAYMENT

Bills for service rendered hereunder are payable within 20 (twenty) days from due date and if not paid within such period become delinquent and subject to charges as set forth in the utility's rules and regulations.

### DELIVERY PRESSURE

The delivery pressure to the consumer will be determined by the pressure available in the utility's mains at the consumer's location.

### TAX PROVISIONS

In the event any privilege, license, franchise, use, occupational or other similar tax is imposed upon the utility by any governmental authority, either federal, state or local, in excess of those in effect on November 1, 2017, there shall be added to the above rates and charges an amount calculated on a pro-rata basis sufficient to recover any such tax or taxes.

### GENERAL

The amount calculated at the above rate will be increased or decreased under the provisions of the utility's rate "PGA" (Purchase Gas Cost Adjustment) by applying the effective PGA factor.

This rate schedule supersedes and replaces Rate "2-2" dated November 1, 2017 and applies to all billing rendered for Industrial Service on or after November 1, 2022 and shall continue from month to month until rescinded.

For industrial facilities that require two or more meters for a single site to accommodate a common process, manufacturing line or a single facility, and where Riviera Utilities and the industrial customer determine the best approach for providing gas is to use multiple meters to the facility, the usage will be based on the cumulative total of all meters, and the base charge will be the base charge for this rate multiplied by the number of meters provided to the process or manufacturing line of a single facility.

### TERM OF CONTRACT

Service under this classification shall be for a minimum period of one year and thereafter until terminated by ninety (90) days written notice by either party to the other, or as specified in the contract for service.
