### AVAILABILITY

Available in all areas served by the Utility's transmission and/or distribution systems. The Utility, being subject to the dictates of its suppliers and governmental agencies, both state and federal, regarding quantity and "end-use" of this commodity, consequently makes no commitment that service will be continuous.

### APPLICABILITY

Applicable for service on an interruptible basis to any customer primarily engaged in a business activity where a gas load requires a meter size of 1000 or smaller. This includes, but is not limited to most retail centers, professional services, trade services, restaurants, hotels and similar places of commerce or other services that may be defined Small Commercial by the Utility. Service shall not be resold or shared.

### MONTHLY RATE

Basic Charge of \$12.50 plus

\$1.65 per 100 cubic feet for the first 1,000 cubic feet; plus

\$1.30 per 100 cubic feet for all over 1,000 cubic feet but less than 50,000 cubic feet; plus

\$0.9750 per 100 cubic feet for all over 50,000 cubic feet

### MINIMUM MONTHLY BILL

Monthly bills for service provided hereunder will not be less than \$12.50.

### PAYMENT

Bills for service rendered hereunder are payable within twenty (20) days from due date and if not paid within such period become delinquent and subject to charges as set forth in the Utility's Rules and Regulations.

### DELIVERY PRESSURE

The delivery pressure to the consumer will be determined by the pressure available in the Utility's mains at the consumer's location.

### TAX PROVISIONS

In the event any privilege, license, franchise, use, occupational, or other similar tax is imposed upon the Utility by any governmental authority, either federal, state or local, in excess of those in effect on November 1, 2017, there shall be added to the above rates and charges an amount, calculated on a pro-rata basis, sufficient to recover any such tax or taxes.

### GENERAL

The amount calculated at the above rate will be increased or decreased under the provisions of the Utility's rate "PGA" (Purchase Gas Cost Adjustment) by applying the effective PGA Factor.

This rate schedule supersedes and replaces Rate "2-1" dated January 1, 2015, and applies to all billing rendered for Small Commercial Service on or after November 1, 2017, and shall continue from month to month until rescinded.

### TERM OF CONTRACT

Service under this classification shall be for a minimum period of one year and thereafter until terminated by ninety (90) days written notice by either party to the other, or as specified in the contract for service.
