FIRST 250,000 Gallons or Less	\$4.10/1,000 Gallons Plus
ALL over 250,000 Gallons	\$5.00/1,000 Gallons

### **6" Meter**

FIRST 325,000 Gallons or Less	\$4.10/1,000 Gallons Plus
ALL over 325,000 Gallons	\$5.00/1,000 Gallons

### **8" Meter**

FIRST 375,000 Gallons or Less	\$4.10/1,000 Gallons Plus
ALL over 375,000 Gallons	\$5.00/1,000 Gallons

## PAYMENT
