UNDERGROUND SERVICE CHARGES

\$20.00 plus \$.70 per linear foot

NOTE: Subscriber is responsible for the cost of installation of necessary conduits, including those required under paved surfaces. Whenever boring under obstacles is required by Riviera, subscriber shall pay as follows:

- Sidewalk, 4' or less \$15.00
- Private Paved Driveway, 12' width or less \$40.00
- Public Street, Driveway more than 12' wide, or other obstaclesActual Cost

OTHER CHARGES

- Relocation of existing outlets, each \$60.00
- Service charges:
 - First 30 minutes (Minimum) \$25.00
 - Each hour thereafter\$30.00 per hour
- Collection charge \$25.00
- Collection & Re-connection charge during normal working hours \$65.00
- Collection & Re-connection charge after 5 PM until 7 PM \$80.00

PAYMENT

Bills for service rendered hereunder are payable on or before the past due date, which is intended to be no less than twenty (20) days from date the bill is rendered. Bills not paid within such period shall be considered as delinquent and are subject to service charges as set forth in the Utility's rules and regulations.

MINIMUM SERVICE PERIOD
