3" Meter

PAYMENT

Bills for service rendered hereunder are payable within fourteen (14) days from due date and if not paid within such period become delinquent and subject to charges as set forth in the Utility's Rules and Regulations.

TAX PROVISIONS

In the event any privilege, license, franchise, use, occupational, or other similar tax is imposed upon the Utility by any governmental authority, either federal, state or local, in excess of those in effect on January 1, 2015, there shall be added to the above rates and charges an amount, calculated on a pro-rata basis, sufficient to recover any such tax or taxes.

TERM OF CONTRACT

Service under this classification shall be for an initial period of at least one year and thereafter from year to year until terminated by written notice.
