### AVAILABILITY

This rate is available to consumers in all areas served by the Utility currently taking service under Rate 600 or Rate 604.

### APPLICABILITY

Applicable for any customer currently being served under the Utility's Rate 600 or 604 who has installed a renewable electric generating facility that meets the requirements of the Utility's Interconnection Agreement for such facilities, has completed an Application to Interconnect Customer-Owned Small Renewable Generation, has executed the Utility's Interconnection Agreement and Agreement for Sale and Purchase of Electric Energy Produced by Customer-Owned Small Renewable Generation, and desires a permanent electrical connection with the Utility's distribution system in order to sell alternate electrical energy to the Utility.

### CHARACTER OF SERVICE

Single-phase renewable (solar or wind) 60 Hertz service at available secondary voltages.

### MONTHLY RATE

#### CUSTOMER CHARGE:

*In addition to the Customer Charge under Rate 600 or 604 as applicable*

\$3.00 for services requiring a single-phase meter; or

\$4.00 for services requiring a three-phase meter

#### CREDIT FOR ENERGY RETURNED:

4.2350¢ per kWh for all kWh's received by the Utility

### GENERAL

This rate rider is for the accommodation of renewable generation. It applies in addition to all billing rendered for electric service under Rates 600 or 604 on or after February 1, 2023, and shall continue from month to month until rescinded. The Monthly Customer Charge shown above is to be paid in addition to the Customer Charge included in Rate 600 or 604 to cover the cost of meter configuration, meter reading, data processing and miscellaneous expenses necessary for the proper accounting of electrical energy returned to the Utility's distribution

system by the Customer. The credit for energy returned is the per kWh credit issued by the Utility acting as the agent for the Alabama Municipal Electric Authority (AMEA) to the Customer for energy returned to the Utility's distribution system by the Customer. All conditions and provisions of the Utility's Renewable-Behind-The-Meter-Generation program apply to and are considered a part of this rate rider.

### PAYMENT

The Customer will receive credit for energy returned to the Utility's distribution system on the regular monthly billing. In the event that a given monthly credit for excess Customer-produced electric energy exceeds the total billed amount for Customer's consumption of electricity supplied to the Customer by the Utility at retail in any corresponding month, then, the excess credit shall be applied to the subsequent month's bill, and to the extent not then fully utilized, succeeding months' bills; provided, however, that credits not fully utilized to offset amounts owed by Customer for retail electric service within twelve (12) months of the month in which they originated shall be paid to the Customer by the Utility. All other payment requirements under Rate 600 or 604 will apply for electricity purchased by the Customer from the Utility.
