NOTE 1: Fox Sports South requires an additional \$37.50 charge to a restaurant or lounge for each of their programming channels to be included in our Basic Plus package. Riviera Utilities Cable will block this service unless an establishment wants to add Fox Sports South to their Basic Plus service. If an establishment wants the Fox Sports South programming, the total monthly charge for Basic Plus service will be \$93.75 plus an additional \$37.50 for Fox Sports South.

NOTE 2: Premium Service(s) are <u>not</u> available to any subscriber under this rate classification.

INSTALLATION REQUIREMENTS
